

Dear Ms. Chow and Dr. Lau:

How are you? Please accept my heartfelt thanks for your love toward my handicapped son, Li Por. Thank you for coming again and again to visit him. Thank you also for donating the wheelchair, which allows this poor child to once again experience the world outside.

For nine years, Li Por was unable to go out of the house. He lived in an isolated world. As parents, we felt that we had failed. When for the first time he used his left hand to write the article [My Story], a child who had not written for nine years expressed his feelings to Ms. Chow. As his mother I was particularly sad because this was the first time I knew what he wanted to say. He did not want to talk to us. He knew that he was born into a poor family. We did not even have enough for our daily living. Each time the new school year started, it was a sad time for Li Por. Since age eleven he has not been able to attend school. Other people live in nice houses and enjoy having meat daily. We could only afford a small portion of meat every third or fifth meal. Nevertheless, Li Por said I love to eat what you give me. He is a good child. For so many nights and days tears accompanied me. These were tears of sorrow and pain.

Today we went out for the whole day. Li Por became tired and went to bed early, but I cannot sleep at all. My tears keep coming. These are tears of joy and thanksgiving. I remember very vividly everything that happened during the day. Thank you for Dr. Miu, who took us in a van to different places to shop for a wheelchair and a walking aid. Mr. Cheung from the TV station took pictures for us, and this is a beautiful memory that we will remember for a lifetime. Li Por was able to go to the park by the riverside with his new wheelchair and look at the wonderful scenery and the grand bridge over the water. All this could not have happened without your loving care. Ms. Chow and Dr. Lau were very considerate and presented some drawings to Li Por. You did what we as parents were not able to do. This gave my son great encouragement. It has been nine years since the operation left my son paralyzed. Initially, he was unable to move; later, he was able to sit up. Li Por made a great effort to crawl by holding onto a metal rod. Many times he tore his clothes while exercising. Eventually he was able to take some steps holding onto a chair. Every step represented the strength of his will to get better. Every step was difficult and painful. There were many tears of sorrow. At times his life seemed about at its end. After Mr. Cheung learned about Li Por, however, he came to help him. He gave him books and taught him drawing. He came to visit him regularly. He was like a candle whose small flame became the light of Li Por. Since then Li Por has had hope, and now we meet you. You are a blessing for our child sent directly from God.

Friends from afar, please tell the story of my child wherever you go. Hope that he will find people who will love him and care for him and give him a hand to assist him along his life journey and make it a success. I extend my sincere thanks to you and to all who have helped him. May peace be with you always.
